Subject: Filling up one post of Junior Translator (General Central Service, Group - 'B' Non - Gazetted, Ministerial) in Central Fertiliser Quality Control & Training Institute, Faridabad (A subordinate office under the administrative control of Department of Agriculture & Farmers Welfare) in the Level-6 of Pay Matrix (7th CPC- Rs. 35,400-1,12,400/-) (pre-revised pay scale of Rs. 9300-34800/- with a Grade Pay of Rs. 4200/- PB-2) on deputation (including short term contract) basis-reg.

It is proposed to fill up one post of Junior Translator (General Central Service, Group - 'B' Non - Gazetted, Ministerial) in Central Fertiliser Quality Control & Training Institute, Faridabad (A subordinate office under the administrative control of Department of Agriculture & Farmers Welfare) in the Level-6 of Pay Matrix (7th CPC- Rs. 35,400-1,12,400/-) (pre-revised pay scale of Rs. 9300-34800/- with a Grade Pay of Rs. 4200/-, PB-2) on deputation (including short term contract) basis.

2. Eligibility Conditions: - Deputation (including short term contract).

Officers under the Central Government or State or Union Territories Administration or Universities or Recognized Research Institutions or Public Sector Undertakings or Semi Government or Statutory or autonomous organizations :-

- (a) (i) holding analogous posts on regular basis in the parent cadre/Department;
(b) Possessing the education qualification:

Essential:

Master's degree of a recognized University in Hindi with English as a compulsory or elective subject or as the medium of examination at the degree level;

OR

Master's degree of a recognized University in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level.

OR

Master's degree of a recognized University in any subject other than Hindi or English, with Hindi medium and English as a compulsory or elective subject or as the medium of a examination at the degree level.

Or

Master's degree of a recognized University in any subject other than Hindi or English, with English medium and Hindi as a compulsory or elective subject or as the medium of a examination at the degree level.

OR

Master's degree of a recognized University in any subject other than Hindi or English, with Hindi and English as compulsory or elective subjects or either of the two as a medium of examination and the other as a compulsory or elective subject at the degree level;

AND

Recognized Diploma or Certificate course in translation from Hindi to English and vice versa or two year's experience of translation work from Hindi to English and vice versa in Central or State Government office, including Government of India Undertaking.

The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

3. Duties and responsibilities attached to the post:

To translate all the matters from English to Hindi and vice versa, to assist the officers to translate all the technical matters/lectures in Hindi, perform various activities provided under Rajbhasha Act, preparation of quarterly and annual Hindi Reports and participate in all the meetings are being organized on Rajbhasha from time to time.

4. Regulation of Pay and other terms of deputation:-

The pay of the officer selected for appointment on deputation basis will be regulated in terms of DOPT's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.

5. Age- limit:-

The maximum age limit for appointment by deputation (Including Short Term Contract) shall be not exceeding 56 years as on the date of closing date of the receipt of applications.

6. Period of deputation: -

Period of deputation (Including Short Term Contract) including the period of deputation (Including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of Central Government shall ordinarily not exceed three years.

For the purpose of appointment on deputation (including Short Term Contract) or absorption basis, the service rendered on a regular basis by an officer prior to 1st January 2006 or the date from which the revised pay structure based on the 6th Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common pay or pay scale and where this benefit will extend only for the posts for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

7. Place of posting:- Central Fertiliser Quality Control & Training Institute, Faridabad.

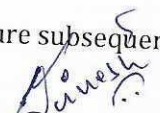
