Sub: Filling up the post of Managing Director (MD) in MP Power Generating Company Ltd., Jabalpur – reg.

After unbundling of Madhya Pradesh State Electricity Board (MPSEB), separate companies (one Generation, one Transmission, Three Distribution and one Power Management Company) have been formed by the Government of Madhya Pradesh. These companies have been granted autonomy with effect from 1st June 2005. M.P. Power Generating Company Ltd., Jabalpur is looking after the work of power generation in the State.

2/ Government of MP is seeking a suitable candidate to appoint as the Managing Director of MP Power Generating Company Ltd. with headquarter at Jabalpur. The MD of the company in his capacity as CEO, will be responsible for overall management of the company with focus on improving performance of the company. The incumbent should have a proven track record and have the initiative, capacity and drive to lead organizational transformation. The responsibilities of the MD include development and implementation of the company's business plan, ensuring improvement in operational and financial performance and managing key stakeholders. The MD shall get a pay scale of Executive Director of the Company (M.P. Power Generating Co. Ltd.) with similar perquisites, subject to reduction by an amount of pension / pension equivalent as per prevailing rules.

3/ The candidate's age should not be more than 60 years at the time of making application and shall be appointed for the duration of not more than three years. The selected candidate shall be eligible for reappointment for one more term of period not exceeding 3 years subject to the recommendations of the Selection Committee constituted for the purpose, and has not crossed the age of 60 years at the time of making application for reappointment.

4/ The candidates fulfilling above criteria, with experience in Administrative / Technical / Finance or Management functions having worked as Additional Chief Engineer or above in the respective cadre preferably in Power Sector Company, may submit their application in the format annexed herewith by post at the address given below in advance along with curriculum vitae and details of two referees. **Last date for receipt of applications is 07.08.2026.**
